Relevance of the dissertation topic

Agricultural trade is an important component of world commodity trade, and the total export trade is used to represent the scale of agricultural trade. However, it is influenced by both the economic policies of various countries and global macroeconomic trends, as well as the characteristics of agricultural products themselves. The elasticity of demand for agricultural products is small, and changes in climate and years often lead to significant changes in the supply of agricultural products. These characteristics have caused long-term instability in global agricultural production and prices. However, since the 1980s, the commodity structure of international trade in goods has undergone significant changes. The development speed of world agricultural trade is constantly declining. This trend is in line with the requirements of the current global economic development pattern, as with the continuous development of economies in various countries, both developed and developing countries have experienced or are undergoing changes in their domestic industrial structures. The proportion of the tertiary industry (service industry) has increased, while the proportion of the primary industry (agriculture) continues to decline.

The regional structure of agricultural trade is mainly dominated by Europe, Asia, the Americas, and developed countries. The distribution of the world agricultural trade pattern is uneven. Both exports and imports are dominated by developed countries. The main import and export regions are Europe, followed by Asia and the Americas. The competition in agricultural trade is incomplete. A few agricultural exporting countries monopolize their advantageous agricultural trade. Especially developed countries often

have clear competitive advantages in agricultural product trade. The reason is that developed countries maintain extensive agricultural protection policies and means.

This study combines the characteristics and current situation of agricultural product trade, analyzes the international trade import and export volume of various agricultural products, as well as the agricultural product trade situation of major continents and major agricultural product trading countries around the world. It explores the factors that affect the development of agricultural product trade, such as natural resource endowment and industrial structure composition. Has important theoretical and practical significance; In addition, the formulation of international trade policies for agricultural products must be based on a foundation that is conducive to the comprehensive and balanced development of the agricultural industry and the national economy. The healthy development of international trade in agricultural products has important practical significance.

Validity and novelty of research results

The scientific novelty of research is inherent in various parts of a paper. The scientific novelty obtained is that from the perspective of globalization, the trade scale, structure, competitiveness, and complementarity of the global agricultural market were studied and analyzed through statistical calculations of agricultural trade data from major continents and agricultural countries around the world. And systematically constructed a research framework on the impact of global agricultural trade on agricultural development and economic growth.

For the first time the author:

1.Based on the perspective of globalization, the research perspective is relatively broad. Selecting agricultural product trade data from 2011 to 2020, the trade scale and

development of the global agricultural product market are dynamically displayed through charts. This is different from previous studies that only studied agricultural product trade from one or more markets, one or more types of agricultural products;

- 2. Using system analysis and empirical testing, apply two research paths: from the agricultural product market to the research path of agricultural products. What agricultural products are produced and what kind of agricultural product industry structure has been established. The research path from specific agricultural products to agricultural product markets analyzes the main import and export trade markets, trade scale, and trade flow of one or more types of agricultural products. A comprehensive analysis of agricultural product trade has been conducted, which makes up for the limitations of studying agricultural products only from the agricultural product market or a certain category of agricultural products in the past;
- 3. Through research and analysis of the global agricultural market and key agricultural product production, the author believes that promoting agricultural technological progress, optimizing agricultural industrial structure, and adopting active and effective government policies are all effective measures to expand agricultural trade.

Practical significance of the obtained results

This study combines the characteristics and current situation of agricultural product trade, analyzes the international trade import and export volume of various agricultural products, as well as the agricultural product trade situation of major continents and major agricultural product trading countries around the world. It explores the factors that affect the development of agricultural product trade, such as natural resource endowment and industrial structure composition. The formulation of international trade policies for agricultural products must be based on a foundation that is conducive to the comprehensive and balanced development of the agricultural industry and the national economy. This has important practical significance for the healthy development of international trade in agricultural products.

Characteristics of the academic integrity of the acquirer

Zhang Fenghe dissertation was checked for academic plagiarism using a licensing program. The analysis of the results of checking Zhang Fenghe dissertation for academic plagiarism, taking into account the explanations provided regarding the coincidence of some part of the dissertation with Zhang Fenghe articles, shows the absence of academic plagiarism, self-plagiarism, fabrication, falsification, etc.

Recommendations and comments on the dissertation work

Noting positively the level of scientific and practical value of the dissertation, it is necessary to note a number of remarks:

- 1. The world agricultural trade market has a wide range and a long existence. The research paper only selected the agricultural trade status of some major countries (regions) in the world from 2011 to 2020, which is one-sided; If conditions permit, it is best to expand the time interval of the research subjects.
- 2. There are many factors that affect global agricultural trade, such as tariff barriers, technological barriers, government policies, etc. If the author can take these factors into account in the research, then this scientific work will have greater practical significance. In addition, this paper mainly studies the import and export trade volume of different agricultural product trade markets around the world, as well as the competitive and complementary characteristics between trade markets.
- 3. The third part of the paper does not explain the phased characteristics of Ukraine and China's agricultural trade development from the perspective of geoeconomics.

The opinions and suggestions expressed are not fundamentally meaningful, some are controversial, do not affect the value of the paper, and do not reduce the overall positive evaluation of the content of the paper. This is an important scientific and practical issue that will contribute to the development of world agricultural trade.
